in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of Six Thousand, Two Hundred & No/100

(\$6,200.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of Fifty and No/100

(\$ 50.00) Dollars upon the first
