SEND GREETINGS:

Whereas, I the said G. W. Turner
in and by my certain promissory note in writing, of even date with these presents, am
well and truly indebted to Citizens Lumber Company, a corporation, Greenville, S. C.

in the full and just sum of One Thousand & No/100 ¹⁹⁴²
(\$ 1,000.00) Dollars, to be paid \$15.00 on January 1, 1942, and \$15.00
on the first day of each successive month thereafter until the whole amount is paid in full,
said payments to be first applied to interest balance to principal.

with interest thereon from January 1, 1942 at the rate of Six ^{6%} per centum per annum, to be computed and paid monthly as above stated
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land, with the improvements thereon or to be constructed thereon, situate, lying and being in Gantt Township, Greenville County, State of South Carolina, near Gantt School, being shown as Lot No. 5 on plat of Property of C. O. Berry made by H. S. Brockman, Surveyor, August 9, 1941, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book M at Page 29, and described as follows:
Beginning at a stake on the South side of Hillcrest Drive, 332 feet East from the White Horse Road, corner of Lot No. 4, and running thence with the line of said lot S. 1-07 E. 145.2 feet to a stake; thence S. 85-45 E. 50 feet to a stake, corner of Lot No. 6; thence with the line of said lot, N. 1-07 W. 148.8 feet to a stake on Hillcrest Drive; thence with the Southern side of Hillcrest Drive, S. 89-50 W. 50 feet to the beginning corner; being the same property conveyed to G.
