I, Edna S. Merritt, of Greenville County, State of S. C., SEND GREETINGS:

WHEREAS I, Edna S. Merritt

in and by my Edna S. Merritt certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C. in the full and just sum of Forty-three Hundred & No/100

(\$ 4300.00) Dollars,

with interest at the rate of (6%) per centum per annum, to be repaid in installments of Thirty-six & 29/100

(\$ 36.29) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That Edna S. Merritt

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Fidelity Federal Savings and Loan Association, of Greenville, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to the said Fidelity Federal Savings and Loan Association, of Greenville, S. C.

the said Edna S. Merritt in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property, to-wit:

"All that certain piece, parcel or lot of land with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, on the North side of Club Drive, near the City of Greenville, being known and designated as Lot No. 39, as shown on plat recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book B at Page 153, and being more particularly described as follows:

Beginning at an iron pin on the North side of Club Drive, corner of Lot No. 38, and running thence with the line of said lot in a northerly direction 170.3 feet to an iron pin, corner of Lot No. 30; thence with the line of said lot in an Easterly direction 76.5 feet to an iron pin, corner of Lot No. 40; thence with the line of said lot in a Southerly direction 171.6 feet to an iron pin in Club Drive; thence with the Northern side of Club Drive in a westerly direction 79 feet to the beginning corner, less, however a strip approximately 5 feet wide taken from the front of said lot to widen Club Drive; being the same property conveyed to Edna S. Merritt by Helen D. Gullick by deed dated September 21, 1935, recorded in the R. M. C. Office for Greenville County, S. C., in Book of Deeds 181 at Page 398."
