**All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Southwest side of Aberdeen Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 17 on revised map of Park Hill made by Dalton & Neves, May, 1940, recorded in the R. M. C. Office for Greenville County, S.C. in Plat Book J, at pages 208 and 209, and having, according to said plat and a recent survey made November 29, 1941, by R. E. Dalton, Engineer, the following metes and bounds, to-wit:-**

**BEGINNING at an iron pin on the Southwest side of Aberdeen Drive, joint front corner of Lots 16-A and 17, said pin also being 393.3 feet in a Southeasterly direction from the point where the Southwest side of Aberdeen Drive intersects with the Southeast side of Aberdeen Avenue, and running thence with the line of Lot 16-A, S. 38-54 W 157 feet to an iron pin; thence with the line of property belonging to the Estate of M. D. Earle, S. 45-39 E. 88 feet to an iron pin; thence with the line of Lot No. 18 N. 34-37 E. 170.9 feet to an iron pin on the Southwest side of Aberdeen Drive; thence with the Southwest side of Aberdeen Drive N. 54-53 W. 75 feet to the beginning corner.**
