I, Mary Alese McCormack, of Greenville County, S. C., SEND GREETINGS:

WHEREAS I _____ the said Mary Alese McCormack

in and by my _____ certain promissory note,*in writing, of even date with these presents, am _____ well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of Twenty-seven Hundred & No/100 (\$ 2700.00) Dollars,

with interest at the rate of (6%) per centum per annum, to be repaid in installments of Twenty-seven & No/100
