MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Julius E. Robinson and Louise S. Robinson of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto The Penn Mutual Life Insurance Company, a corporation organized and existing under the laws of State of Pennsylvania, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **thirty one hundred fifty & no/100** dollars (\$ 3150.00), with interest from date at the rate of **four and one-half** per centum ($4\frac{1}{2}$ %) per annum until paid, said principal and interest being payable at the office of The Penn Mutual Life Insurance Company in Philadelphia, Pa. or at such other place as the holder of the note may designate in writing, in monthly installments of **Seventeen & 51/100** Dollars (\$ 17.51), commencing on the first day of August, 19 42, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of July, 19 67.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land in Greenville Township, near the City of Greenville, and known and designated as Lot No. 12 on plat of property of Glenn Grove Park recorded in the R. M. C. Office for Greenville County in Plat Book "F", page 233, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of Grace St. and Cooledge Avenue, joint corner of Lots Nos. 11 and 12, and running thence with the line of Lots Nos. 11 and 12 N. 74-12 W. 150 feet to joint rear corner of Lots Nos. 11, 12, 41 and 42; thence along the rear line of Lot No. 41 N. 15-48 E. 50 feet to joint rear corner of Lots Nos. 12, 13, 40 and 41; thence along the line of Lots Nos. 12 and 13 S. 74-12 E. 150 feet to an iron pin on Cooledge Ave.; thence along Cooledge Ave. S. 15-48 W. 50 feet to the point of beginning.

The Mortgagor further agrees that should this mortgage and the note secured hereby not be eligible for insurance under the National Housing Act within eight months from the date hereof (Written statement of any officer or employee of the Federal Housing Administration dated subsequent to the eight months' time from the date of this mortgage, declining to insure said note and this mortgage, being deemed conclusive proof of such ineligibility) the Mortgagee or the holder of the note may, at its option, declare all sums secured hereby immediately due and payable.

The debt secured hereby having been paid in full, The Penn Mutual Life Insurance Company, mortgagor, herein declares this mortgage cancelled.
