all that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, known and designated as Lot No. 3 of Augusta Road Ranches as shown on plat made by Dalton & Neves April 1941, and recorded in the R. M. C. office for Greenville County, S. C. in Plat Book L, pages 52 and 53, and having according to said Plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Old Augusta Road, joint corner of Lots Nos. 3 and 4, and running thence with Old Augusta Road N. 4-42 E. 60.25 feet to an iron pin, joint corner of Lots Nos. 2 and 3; thence along the dividing line of said lots S. 89-47 W. 258 feet to an iron pin, joint rear corner of Lots Nos. 2 and 3; thence along the rear line of Lot No. 3, S. 0-13 E. 60 feet to an iron pin; joint rear corner of Lots Nos. 3 and 4; thence along the dividing line of said lots N. 89-47 E. 252.8 feet to the point of beginning.
