(\$ 2,500.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in installments of

Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"BEGINNING at an iron pin on the north side of Colonial avenue, joint corner of Lots 17 and 18, of Block V, which point is 150 feet west from the northwest corner of the intersection of Greene street and Colonial avenue, and running thence along the joint line of said lots, N. 10-15 E. 125 feet to an iron pin on a 15-foot alley; thence along the line of said alley, N. 79-45 E. 50 feet to an iron pin, joint rear corner of Lots 16 and 17; thence along the joint line of said lots, S. 10-15 W. 125 feet to an iron pin, on the north side of Colonial avenue; thence along the line of Colonial avenue, S. 79-45 E. 50 feet to the beginning corner. Being the same lot conveyed to us by Allen Cathcart and Marie Cathcart by deed of even date herewith, not yet recorded."
