Whereas, I the said Bonnie K. Campbell  
in and by my certain promissory note in writing, of even date with these presents, AM  
well and truly indebted to E. L. Craigo  
in the full and just sum of One Thousand & No/100  
(\$1,000.00) Dollars, to be paid one year from date

with interest thereon from date at the rate of 6 per centum per annum, to be computed and paid  
semi-annually until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to  
become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should  
be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection  
of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either  
of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mort-  
gage indebtedness, and to be secured under this mortgage as a part of said debt.

E. L. Craigo, his Heirs and Assigns forever, the following described property:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the corporate limits of the City of Greenville on the north side of First Avenue (now Fair Street) and having a frontage of 50 feet on said First Avenue, with a depth in parallel lines of 145 feet, and known and designated as Lot No. 10, Block "N" as shown on Plat Book "A", page 119, R. M. C. Office for Greenville County.
