"Beginning at an iron pin on the Western side of Woodland Drive, corner of tract No. 32, and running thence with the line of said tract approximately N. 71-17 W. 830 feet to an iron pin on branch; thence with the meanderings of said branch approximately S. 45-44 W. 165.5 feet to an iron pin, rear corner of tract No. 30; thence with the line of said tract approximately S. 71-17 E. 900 feet to an iron pin on Woodland Drive; thence with the Western side of Woodland Drive N. 18045 E. 150 feet to the point of beginning. Said premises being the same conveyed to the mortgagors by R. M. Caine and W. E. Razor by deed dated May 16, 1939 and recorded in the R. M. C. Office for Greenville County in Book of Deeds 210, at page 382.
