WHEREAS I, the said Sarah A. Hill

SEND GREETINGS:

in and by my certain promissory note, in writing, of FIDELITY FEDERAL SAVINGS & LOAN ASSO. AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the amount of TWO HUNDRED AND NO/100

PAID AND SATISFIED IN FULL THIS 4th DAY OF August 1943 FIDELITY FEDERAL SAVINGS & LOAN ASSO. WITNESSES: Margaret A. Means, Lottie West

(\$ 200.00) Dollars,

with interest at the rate of (6%) per centum per annum, to be repaid in installments of SEVENTEEN AND 12/100

(\$ 17.12) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I, Sarah A. Hill,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me,

the said Sarah A. Hill in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property, to wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Greenville Township, on the Western side of Henrietta Avenue, known and designated as Lot #44 on plat of the property of G. F. Cammer, recorded in Plat Book L, Page 115, and having according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin corner of Lot #43 and running thence with the line of said lot N. 46-43 W. 265.6 feet to iron pin in rear line of Lot #33; thence with rear line of lots 33 and 32 S. 35-07 W. 74.6 feet to iron pin, corner of lot #45; thence with the line of said lot S. 46-43 E. 281 feet to iron pin on Henrietta Avenue; thence with the Western side of Henrietta Avenue N. 23-17 E. 73 feet to the beginning corner. Said property being the same conveyed to the mortgagor by deed from G. F. Cammer dated December 28, 1942.

The within mortgage is given to secure an additional loan on the within described property on which the Fidelity Federal Savings and Loan Association now holds a first mortgage. Proceeds of this loan are to be used to alter the house into a two-family apartment house.
