We, O. C. Berry and Alma E. Berry, of Greenville, S. C. SEND GREETINGS:

WHEREAS I we the said O. C. Berry and Alma E. Berry

in and by my certain promissory note, in writing, of even date with these presents. am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of THREE THOUSAND, ONE HUNDRED & NO/100

(\$ 3,100.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of THIRTY-ONE AND NO/100 (\$ 31.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and to the said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Greenville Township, near the City of Greenville, in the subdivision known as Kanatenah, and situated on the north side of Oregon street, and being known and designated as Lot No. 9, of Block C, on plat of said subdivision recorded in the R. M. C. office for Greenville County in Plat Book F, at pages 66 and 67, (revised plat recorded in Plat Book F, pages 130 and 131), and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of Oregon street, at the joint corner of Lots 9 and 10, of Block C, which point is 60 feet west of the northwest corner of the intersection of Oregon street and Mitchell street, and running thence with Oregon street, S. 63-30 W. 60 feet to an iron pin, joint corner of Lots 8 and 9, of Block C; thence along the joint line of said lots, N. 26-30 W. 165 feet to an iron pin at the corner of Lot No. 18; thence N. 63-30 E. 60 feet to an iron pin, rear corner of Lot No. 10, of Block C; thence along the line of said Lot No. 10, S. 26-30 E. 165 feet to the beginning corner.
