WHEREAS, the Mortgagor is well and truly indebted unto Liberty Life Insurance Company

called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Forty-two Hundred Fifty and No/100 Dollars (\$ 4,250.00**), with interest from date at the rate of **four and one-half** per centum ( $4\frac{1}{2}$  %) per annum until paid, said principal and interest being payable at the office of **Liberty Life Insurance Company** in **Greenville, S.C.**, or at such other place as the holder of the note may designate in writing, in monthly installments of **Twenty-three and 63/100** Dollars (\$ **23.63**), commencing on the first day of **August**, 19 **43**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **July**, 19 **68**.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Northwest side of High Hill Street, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 56, on plat of Augusta Road Hills, made by Dalton & Neves, Engineers, December 1940, recorded in the R. M. C. Office for Greenville County, S.C., in Plat Book L, at pages 56 and 57, and having, according to said plat and a recent survey made by R. E. Dalton, June 10th, 1943, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the Northwest side of High Hill Street at joint front corner of Lots No. 56 and 57, said pin also being 60.2 feet in a Northeasterly direction from the point where the Northwest side of High Hill Street intersects with the North side of Long Hill Street and running thence with the Northwest side of High Hill Street, N. 42-10 E. 60 feet to an iron pin at joint front corner of Lots No. 55 and 56; thence with the line of Lots No. 55 N. 47-50 W. 165 feet to an iron pin; thence with the rear line of Lot No. 37, S. 42-10 W. 60 feet to an iron pin; thence with the line of Lot No. 57, S. 47-50 E. 165 feet to an iron pin on the Northwest side of High Hill Street, the beginning corner.
