NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

**All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the West side of Old Augusta Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 21 on plats of Augusta Road Ranches, made by Dalton & Neves, Engineers, April 1941, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book L, at pages 52 and 53, and also Plat Book M, at page 47, and having, according to said plats, and a recent survey made by R. E. Dalton July 20, 1943, the following metes and bounds, to-wit:-**

**BEGINNING at an iron pin on the West side of Old Augusta Road at joint front corner of Lots No. 20 and 21, said pin also being 75.4 feet/ from the Southwest corner of the intersection of Old Augusta Road and DeOley Avenue and running thence along the West side of Old Augusta Road, S. 5-0 W. 50.2 feet to an iron pin at joint front corner of Lots No. 21 and 22; thence with the line of Lot No. 22, S. 89-47 W. 189.6 feet to an iron pin on the East side of a 15 foot alley; thence with the East side of said alley N. 0-13 W. 50 feet to an iron pin; thence with the line of Lot No. 20, N. 89-47 E. 194.2 feet to an iron pin on the West side of Old Augusta Road, the beginning corner.**
