in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to  
FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of THREE THOUSAND AND NO/100

(\$3,000.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of THIRTY AND NO/100  
(\$ 30.00) Dollars upon the first

"BEGINNING at an iron pin on the north side of East Washington Road at the joint corner of Lots Nos. 88 and 89, of Block E, which point is 250 feet west from the north-west corner of the intersection of Ebaugh avenue and East Washington Road, and running thence along the joint line of said lots, N. 17-30 W. 167 feet to an iron pin on an alley; thence along the line of said alley, S. 27-30 W. 50 feet to an iron pin, joint rear corner of Lots Nos. 89 and 90; and running thence along the joint line of said lots, S. 17-30 E. 167 feet to the joint corner of said lots on north side of East Washington Road; thence along the line of said East Washington Road, N. 27-30 E. 50 feet to the beginning corner.
