I, Lila Mott Richbourg, of Greenville, S. C. SEND GREETINGS:

WHEREAS I, the said Lila Mott Richbourg

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

Four Thousand, Seven Hundred & No/100

(\$ 4,700.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of

Forty Seven and No/100 (\$ 47.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said Lila Mott Richbourg

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Greenville Township, just outside the City of Greenville, on the west side of Jones Avenue, and being known and designated as Lot No. 43, on a plat of the Crescent Terrace property made by R. E. Dalton, C. E., in July, 1919, recorded in Plat Book E, at page 137, and having, according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the west side of Jones avenue, joint corner of Lots Nos. 43 and 44, which point is approximately 986.3 feet north of the northwest intersection of Augusta Road and Jones avenue, and running thence with said Jones avenue, N. 0-50 E. 70 feet to an iron pin, joint corner of Lots 42 and 43, (which point is approximately 425 feet south of the City Limits line); thence along the joint line of Lots 42 and 43, N. 89-10 W. 219.5 feet to an iron pin; thence S. 2-08 E. 70 feet to an iron pin, joint rear corner of Lots 43 and 44; thence along the joint line of said lots, S. 89-10 E. 215.9 feet to the point of beginning. Being the same lot conveyed to me by G. F. Thompson by deed dated Sept. 19, 1939, and recorded in the R. M. C. office for Greenville County in Deed Book 214, page 64."
