All that piece, parcel or lot of land in Grove & Oaklawn Township, Greenville County, State of South Carolina, containing four and three tenths (4.3) acres, more or less, (in the aggregate.)

Adjoining lands of Jerry Davis, Lands of Truman Bennett, Trustee lands of Chas. H. Bennett and State Highway #29.
