All those two certain pieces, parcels or lots of land described as follows:-

(1) All that certain piece, parcel or lot of land situate, lying and being, in the Town of Simpsonville, Austin Township, Greenville County, State of South Carolina, facing southward on Curtis Street with property of W. F. Gresham bounding it on the east and property of P. N. Gresham adjoining it on the west-facing 24 feet more or less, upon said Curtis Street and running back in parallel lines a distance of 100 feet--being the same identical piece of property conveyed to me by T. R. Moore by deed dated September 14, 1940 and recorded in the R. M. C. Office for Greenville County in Vol. at page .

(2) All that certain lot of land situate, lying and being, on McCrary Street, Sans Souci, Greenville Township, Greenville County, State of South Carolina--said lot being #297 of the McCrary Tract as shown on plat of said lands recorded in the RMC Office for Greenville County in Plat Book A at page 278 and 279--said lot having a frontage of 66 feet on McCrary Street and a depth of 123 feet on the east side and 133 feet on the west side and being the same lot of land conveyed to me by Elsie McKinney by deed dated August 7, 1937--which deed is recorded in the R. M. C. Office for Greenville County in Vol. 199 at page 332.
