I, T. C. Greenway, of Greenville County, S. C.

WHEREAS I the said T. C. Greenway

in and by my certain promissory note, in writing, of even date with these presents, well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of

(\$ 4,000.00) Dollars,

with interest at the rate of five (5%) per centum per annum, to be repaid in installments of Thirty-one and 64/100
