Section 204 (g) of the National Housing Act, as amended, ... "The power to convey and to execute in the name of the Administrator deeds of conveyance, deeds of release, assignments and satisfaction of mortgages, and any other written instrument relating to real property or any interest therein heretofore or hereafter acquired by the Administrator pursuant to the provisions of this Act, may be exercised by the Administrator or by any Assistant Administrator appointed by him, without the execution of any express delegation of power of attorney. "

Section 3 of Executive Order No. 9070 dated February 24, 1942... "There shall be three main constituent units in the National Housing Agency. Each such unit shall be administered by a commissioner.... The unit administering the Federal Housing Administration and its functions, powers and duties shall be known as the Federal Housing Administration, and the Federal Housing Administrator shall serve as the Federal Housing Commissioner...."
