TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, T. E. Gibson, of Greenville, S. C.,

WHEREAS I, the said T. E. Gibson

in and by my certain promissory note, in writing, of even date with these presents, well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

Eight Thousand, Two Hundred & no/100

(\$ 8,200.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of Sixty-Eight and no/100

(\$ 68.00) Dollars upon the first

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to

C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Greenville Township, on the west side of Waccamaw Avenue, and being known and designated as Lot No. 51, of a subdivision known as Augusta Circle, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book F, at page 23, and having the following metes and bounds, to-wit:

"Beginning at an iron pin on the west side of Waccamaw Avenue at the joint corner of Lots Nos. 50 and 51, which point is 100 feet north of the northwest corner of the intersection of Waccamaw Avenue and Winyah Street, and running thence along the joint line of Lots 50 and 51, N. 71-35 W. 166.36 feet to an iron pin; thence N. 21-35 E. 50 feet to an iron pin, joint rear corner of Lots Nos. 51 and 52; thence along the joint line of said lots, S. 71-35 E. 166.36 feet to the joint corner of said lots on the west side of Waccamaw Avenue; thence along the west side of Waccamaw Avenue, S. 21-35 W. 50 feet to the beginning corner. Martin; thence along his line, N. 46-32 W. 128.4 feet to an iron pin, rear corner of Lots 58 and 54; thence along the line of Lot No. 54, N. 42-43 E. 199 feet to an iron pin on the south side of Jamison Street, corner of Lots 54 and 55; thence with the line of said Jamison Street, S. 53-40 E. 134.9 feet to the beginning corner.
