in and by my certain promissory note in writing, of even date with these presents,  
well and truly indebted to Joe Rigdon

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain parcel or lot of land situate, lying and being in the County and State aforesaid containing one third of an acre, more or less, on the West side of the extension of Rhett Street in the City of Greenville, through property formerly known as "McBee Hill", and at the Southwest corner of said Rhett St. and a new Street known as Hammond Street, and having the following metes and bounds, to wit:

BEGINNING at a stake on Rhett St., corner of lot #12; thence with the line of lot #12 N. 27-40 W. 157.5 ft. to corner of lot #14; thence with line of lot #14, N. 62-45 E. 61 ft. to stake on Hammond St. thence along Hammond St., S. 27-40 E. 137.5 ft. to Rhett St; thence along Rhett St. S. 48-55 W. 67 ft. to the beginning corner.
