in and by its certain promissory note, in writing, of even date with these presents, is well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of

One Thousand & No/100

(\$1000.00) Dollars,

with interest at the rate of six

(6%) per centum per annum, to be repaid in installments of

Fifteen & No/100

due and payable (\$ 15.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, at the northeast corner of the intersection of Old Paris Mountain Road and Oak Street, being shown as Lot No. 3 on plat of the Property of E. E. Watson, made by G. M. Purman, Jr., C. E., recorded in Plat Book F, Page 11, and having according to said plat, the following metes and bounds:

BEGINNING at a stake at the northeast intersection of Old Paris Mountain Road and Oak Street, and running thence with the northern side of Oak Street, N. 72 E. 120 feet to corner of Lot No. 7; thence with line of Lot No. 7, N. 18 W. 40 feet to corner of Lot No. 2; thence with line of Lot No. 2, S. 72 W. 120 feet to iron pin on Old Paris Mountain Road; thence with the eastern side of Old Paris Mountain Road, S. 18 E. 40 feet to the beginning corner; being the same property conveyed to the Trustees of Brewton Temple Baptist Church by E. E. Watson by deed dated Aug. 19, 1922, recorded in Volume 87, Page 350, and the same lot upon which the church building is now located.
