I, Carlos C. Thompson, of Greenville, S. C.

SEND GREETINGS:

WHEREAS I, the said Carlos C. Thompson

in and by my certain promissory note, in writing, even date with these presents, FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C. well and truly indebted to AND NO/100

(2,500.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of TWENTY-FIVE AND NO/100 (\$ 25.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said Carlos C. Thompson

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to Delcie Farnsworth of GREENVILLE COUNTY, S. C. according to the terms of said note, and also in consideration of the fact that I have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C. the following described property to-wit:

the said Carlos C. Thompson in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Greenville Township, on the southeast side of Perry Road, and being known and designated as Lot No. 2, of the property of L. A. Moseley as shown on Plat thereof made by Dalton & Neves, Engrs., in June, 1940, and recorded in the R. M. C. office for Greenville County in Plat Book J, at page 239, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeast side of Perry Road at the joint corner of Lots Nos. 1 and 2, which point is 60 feet from the southwest corner of the intersection of Perry Road and Newland Avenue, and running thence with the line of Lot No. 1, S. 46-45 E. 145 feet to an iron pin, joint rear corner of said lots; thence S. 43-15 W. 60 feet to an iron pin, joint rear corner of Lots Nos. 2 and 3; thence with the line of Lot 3, N. 46-45 W. 145 feet to the joint corner of said Lots Nos. 2 and 3 on the southeast side of Perry Road; thence along the line of said Perry Road, N. 43-15 E. 60 feet to the beginning corner. Being the same lot conveyed to me by W. F. Duncan by deed of even date herewith not yet recorded."
