in the full and just sum of Sixteen Hundred and No/100 (\$1600.00) Dollars to be paid: \$20.00 on the 13th day of each month hereafter, said payments to be applied first to interest and then to principal until paid in full,

with interest thereon from date at the rate of six (6%) per cent. per annum, to be computed semi-annually monthly until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten (10%) per cent of the amount due thereon

BEGINNING at a point on Hampton Ave. extn. at the center of an eight-foot alley and 95 feet Northwest from the corner of Kelly Ave and Hampton Avenue Extn., and running thence N. 78-38 W. 42 feet 4 1/2 inches to an iron pin; thence S. 17-22 W. 150 feet to an iron pin; thence S. 78-38 E. 47 feet 4 1/2 inches to an iron pin; thence N. 17-22 E. 28 feet to an iron pin in center of alley; thence with center of said alley N. 14-28 E. 121.6 feet to point of beginning.
