Beginning in the center of iron bridge (known as the Ashmore bridge) over Reedy River, thence with road S. 35 W. 2.90 chains to bend; thence with road S. 65 1/2 W. 5 chains to bend; thence with road N. 48 W. 1.40 chains to bend; thence with road N. 67 3/4 W. 2.40 chains to bend; thence with road N. 69 1/2 W. 6.50 chains to bend; thence with road N. 73 3/4 W. 8.80 chains to bend in road; thence with road S. 69 1/2 W. 5.68 chains to bend in road 3xnm; thence S. 61 1/2 E. 26.30 chains to bend in fork of branches; thence down said branch 22.41 chains, the branch as a line, to the river; thence up said Reedy River to the beginning corner, adjoining lands of R.
