SEND GREETINGS:

Whereas, I the said S. C. DeBard  
in and by my certain PROMISSORY note in writing, of even date with these presents,  
well and truly indebted to Citizens Bank, Fountain Inn, S. C.

in the full and just sum of Twenty-five hundred and no/100  
(\$2500.00) Dollars, to be paid one year from date

with interest thereon from date at the rate of five per centum per annum, to be computed and paid semi-annually  
in advance

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land in the Town of Fountain Inn, S. C., on the Northwest side of Cemetery Street, being known and designated as Lot A, as shown on a plat prepared by W. M. Nash, Surveyor, December 29, 1939, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the Northwest side of Cemetery Street, joint corner of Lots A. and B. and running thence N. 16-23 W. along said Gary property, N. 64 1/2 E. 71 feet to an iron pin, corner of McKelvey property; thence along line of McKelvey property, S. 12 1/2 E. 160.6 feet to an iron pin, being the Northwest side of Cemetery Street; thence along the Northwest side of said Street S. 78-05 W. 62.3 feet to the point of beginning.
