All that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate on the West side of Jones Avenue, just outside the corporate limits of the City of Greenville, S. C., being known and designated as Lot No. 44 on plat of Crescent Terrace, a plat of which is recorded in the R. M. C. Office in Plat Book "E", at Page 137, and having, according to survey made by C. M. Furman, Jr., Engineer, October 2, 1930, the following metes and bounds, courses and distances, to-wit:-

BEGINNING at a point on the West side of Jones Avenue, which point is 929.3 feet North of the Northwest corner of the intersection of Jones Avenue and Augusta Street, and running thence N. 89-10 W. 212.2 feet to an iron pin; thence N. 2-08 W. 70.1 feet to an iron pin; thence S. 89-10 E. 215.9 feet to an iron pin on the West side of Jones Avenue; thence along the West side of said Avenue, S. 0-50 W. 70 feet to the point of beginning.
