KNOW ALL MEN BY THESE PRESENTS, That

BESSIE L. BISHOP

of Greenville County and State aforesaid, hereinafter called first party, whether one or more, SEND GREETINGS:  
 WHEREAS, First party is indebted to the Land Bank Commissioner, acting pursuant to Part 3 of the Emergency Farm Mortgage Act of 1933, as amended, hereinafter called second party, as evidenced by a certain promissory note, of even date herewith, for the principal sum of  
**SEVEN HUNDRED** (\$ 700.00 ) Dollars, payable to the order of the second party,  
 together with interest from the date of said note on the principal sum remaining from time to time unpaid, at the rate of **five** per centum per annum,  
 the first payment of interest being due and payable on the **first** day of **November**, 19**45**, and thereafter interest being  
 due and payable **--** annually; said principal sum being due and payable in **fourteen** equal, successive, **--** annual  
 installments of **FORTY SEVEN** (\$ 47.00 ) Dollars each, and a final install-  
 ment of **FORTY TWO** (\$ 42.00 ) Dollars, the first installment of  
 said principal being due and payable on the **first** day of **November**, 19**45**, and thereafter the remaining installments of  
 principal being due and payable **--** annually until the entire principal sum and interest are paid in full; all of which and such other terms,  
 conditions, and agreements as are contained in the said note, will more fully appear by reference thereto.

NOW, KNOW ALL MEN, That first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell and release in fee simple, unto second party, his successors and assigns, the following described lands, to wit:

All that certain piece, parcel and tract of land lying and being situate near the Town of Simpsonville in the County of Greenville and State of South Carolina, containing Fifty Two and 30/100 (52.30) acres, more or less, according to a survey and plat made by W. J. Riddle, Surveyor, under date of February 6, 1945, being bounded on the North by the Pollard lands, on the East by lands of the Estate of C. M. Todd, on the South by lands of the Estate of L. Blakely, and on the West by the King lands. This is the same tract of land conveyed to Mary Emma Murphy by W. D. Staggs and Ella K. Staggs under date of October 5, 1938, by deed recorded in the office of the R. M. C. for Greenville County in book 206, page 160, and is the identical tract of land which was conveyed by the said Mary Emma Murphy Bowers to Bessie L. Bishop by deed recorded simultaneously herewith. The plat above referred to is recorded in book 0, Page 65, and reference is thereto made for a more particular description as to courses and distances and metes and bounds.
