AND IT IS AGREED, by and between the said parties, that ~~I~~ <sup>we</sup> the mortgagor, ~~do~~ <sup>are</sup> to hold and enjoy the said premises until default of payment shall be made. And if at any time any part of said debt, or interest thereon, be past due and unpaid ~~I~~ <sup>we</sup> hereby assign the rents and profits of the above described premises to said
