MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Vernell J. Bouchillon

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Two Thousand Five Hundred and No/100 DOLLARS (\$2,500.00), with interest thereon from date at the rate of five & one-half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Greenville Township, on the Southwestern corner of Frances Avenue and Beatrice Street, near the City of Greenville, being shown as Lot No. 127 on Map No. 2 of Camille Park, made by W. J. Riddle in December, 1943, and described as follows:

BEGINNING at a stake at the southwestern corner of Beatrice St., and Frances Avenue, and running thence with the Southern side of Frances Avenue S. 67-48 W. 202.3 feet to a stake at corner of Lot No. 126; thence with the line of said Lot S. 11-32 E. 81.4 feet to a stake at the corner of Lot No. 128; thence with the line of said Lot N. 67 -48 E. 217.7 feet to a stake on Beatrice Street; thence with the Western side of Beatrice Street N. 21-55 W. 80 feet to beginning corner; being the same property conveyed to the mortgagor by The First National Bank, as Adm. for Jno.
