in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of **Twenty-seven Hundred Fifty and No/100**

(\$ **2750.00** ) Dollars,

with interest at the rate of **five & one-half** ( **5½** %) per centum per annum, to be repaid in installments of

**Twenty-two and 48/100**
