I, Agnes E. Bruns, of Greenville County

SEND GREETINGS:

WHEREAS I, the said Agnes E. Bruns

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to
FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of FIVE THOUSAND AND NO/100

(\$ 5,000.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of THIRTY-SIX AND NO/100

(\$ 36.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said Agnes E. Bruns

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me the said Agnes E. Bruns

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. Gassaway as shown on plat thereof made by Dalton & Neves, Engrs., and recorded in the R. M. C. office for Greenville County in Plat Book H, at page 73, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of Ashley avenue at the joint corner of Lots Nos. 3 and 4, which point is approximately 513.3 feet west from the north-west corner of the intersection of Ashley avenue and North Main Street, and running thence along the joint line of said Lots Nos. 3 and 4, N. 24-38 E. 158.5 feet to an iron pin at the joint rear corner of said lots in the line of property now or formerly belonging to L. O. Patterson; thence along the line of his property, N. 79-25 W. 61.85 feet to an iron pin at the joint rear corner of Lots Nos. 2 and 3 in line of the Patterson property; thence along the line of said Lots Nos. 2 and 3, S. 24-38 W. 143.7 feet, more or less, to the joint corner of said Lots on the north side of Ashley avenue; thence along the line of said Ashley avenue, S. 65-30 E. 60 feet to the beginning corner. Being the same lot conveyed to me by Dorothy Keith Hunter by deed of even date herewith, not yet recorded, this mortgage being given to secure the purchase price thereof.
