BEGINNING at an iron pin at the southwest intersection of Creole Street and Goldfield Street and running thence in a southwesternly direction with Goldfield Street 164.5 feet to an iron pin; thence N. 50 W. 50 ft. to an iron pin, corner of Lot No. 10; thence with the line of said lot N. 40 E. 151 feet to an iron pin on Creole Street; thence with the southern side of Creole Street 60.7 feet to the point of beginning.
