TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, **I**, the said **Ida Heatherly**

SEND GREETING:

in and by **my** certain **Promissory** note in writing, of even date with these presents **am** well and truly indebted to **Citizens Lumber Company, a corporation**

in the full and just sum of **Two Thousand and No/100 --- (\$2,000.00) ---** Dollars
to be paid: **\$20.00 each on the 22nd day of each month hereafter, beginning June 22, 1945;**
said payments to be applied first to interest and then to principal until paid in full

with interest thereon from **date** **semi-annually** at the rate of **six (6%)**
per cent. per annum, to be computed and paid **monthly**
until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of **ten (10%) per cent. of the amount due thereon**

besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind, all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That the said Mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of **Two** Dollars to the said Mortgagor in hand well and truly paid by the said Mortgagee, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain and release unto the said Mortgagee, and **its Successors** and Assigns, forever, all and singular that certain piece, parcel, lot or tract of land and situate, lying and being in **Greenville Township, Greenville** County, State aforesaid,

on the eastern side of McDade Avenue, near the City of Greenville, being shown as Lot No. 107 on Plat of City View, recorded in Plat Book A at Pages 460 and 461, and described as follows:

BEGINNING at a stake on the eastern side of McDade Avenue 300 feet north from O'Neal Street, corner of Lot No. 106, and running thence with the line of said lot S. 89-30 E. 150 feet to a stake on a 10-foot alley; thence with the Western side of said alley N. 00-30 E. 50 feet to a stake, corner of Lot No. 108; thence with the line of said lot N. 89-30 W. 150 feet to McDade Avenue; thence with the eastern side of McDade Avenue S. 00-30 W. 50 feet to beginning corner; said premises being the same conveyed to the mortgagor by B.
