TO ALL WHOM THESE PRESENTS MAY CONCERN:-----

I. L. D. Boylston (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Greenville Township, known and designated as Lots Nos. 11 and 12 as shown on Plat of Lanneau Drive Highlands made by Dalton & Neves, August, 1937, and recorded in Plat Book D at Pages 288 and 289, and when described together have the following metes and bounds according to said plat.

BEGINNING at an iron pin on the Western side of Ponce de Leon Drive, joint corners of lots Nos. 10 and 11 and running thence with line of Lot No. 10, S. 63-47 W. 160 feet to an iron pin; thence with the rear line of Lots Nos. 23 and 22, N. 26-13 E. 100 feet to iron pin, corner of Lot No. 13; thence with the line of said Lot, N. 63-47 E. 160 feet to iron pin on Ponce de Leon Drive; thence with the western side of Ponce de Leon Drive S. 26-13 E. 100 feet to the point of beginning; said premises being the same conveyed to the mortgagor by Annis Elizabeth M.
