BEGINNING at a stake on the eastern side of South Leach Street 40 feet North from Arlington Avenue, corner of property now or formerly owned by Keer Wilson; thence with the line of said lot, S. 69-30 E. 80 feet to a stake; thence N. 19-50 E. 85 feet to a stake, corner of property now or formerly owned by Bessie R. McMahan; thence with the line of said lot, N. 69-30 W. 80 feet to a stake on South Leach Street; thence with the Eastern side of South Leach Street, S. 19-50 W. 85 feet to the beginning corner; being the same premises conveyed to the mortgagor by T.
