Poag; thence along the line of her property N. 38-35 E. 177.9 feet to an iron pin in line of the Poag property; thence N. 68-35 E. 12 feet to an iron pin in the right-of-way of the C. & W. C. Railway; thence along the line of said right-of-way, N. 62-35 W. 169.2 feet to an iron pin at the southwest corner of the intersection of said right-of-way with Eastlan Drive; thence along the west side of Eastlan Drive, S. 36-13 W. 201.5 feet to an iron pin at the beginning corner.
