"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, being known and designated as Lot No. 31, of Section 5, of a subdivision of Judson Mills Village as shown on plat thereof made by Dalton & Neves, Engrs., in February, 1940, and recorded in the R. M. C. office for Greenville County in Plat Book K, at pages 33 and 34, said lot having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northwest corner of the intersection of Tenth street and Honour street, and running thence along the southwest side of Honour street, N. 55-37 W. 145.4 feet to an iron pin on said Honour street at corner of Lot No. 32; thence along the line of Lot No. 32, S. 1-55 E. 86 feet to an iron pin on the north side of Tenth street; thence along the north side of Tenth street, N. 88-09 E. 117.3 feet to the beginning corner. Being the same lot conveyed to me by Jewel L. Sellers by deed of even date herewith not yet recorded, this mortgage being given to secure the unpaid portion of the purchase price thereof."
