WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township on the Southwestern side of Augusta Road about one mile from the corporate limits of the City of Greenville, being shown as Lot No. 7 on Plat property of J. F. Cammer made by R. E. Dalton, Engineer, in February, 1923, and revised in July 1935, recorded in Plat Book L at Page 115 and described as follows:

Beginning at a stake on the Southwestern side of Augusta Road 91 feet North from Henrietta Avenue at corner of Lot No. 8 and running thence with the line of said Lot S. 53-33 W. 261.6 feet to a stake in line of Lot No. 9; thence with the line of said Lot N. 36-24 W. 89.5 feet to a stake at corner of Lot No. 6; thence with the line of said Lot N. 53-33 E. 269.5 feet to a stake on Augusta Road; thence with the Southwestern side of Augusta Road S. 31-18 E. 90 feet to the beginning point.
