all that tract or lot of land in the City of Greenville, Greenville Township, Greenville County, State of South Carolina, on the South side of Elford Street and designated as Lot Number Nine as shown on plat made by W. A. Hudson, D. S., on June 25, 1906, and being described by metes and bounds as follows, to wit:

Beginning at an iron pin at the corner of Lot Number Eight as shown on said plat, and running thence South 35½ West One Hundred Thirty-eight feet to the corner of Lots Eight, Thirteen and Fourteen; thence with the line of Lot Number Fourteen South 55 East Fifty feet to an iron pin; thence North 35½ East One Hundred Forty feet to an iron pin on Elford Street; thence with Elford Street as the line North 58 West Fifty feet to the beginning corner.
