MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, James Edward Jay,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-eight Hundred and No/100 DOLLARS (\$ 2800.00), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, near the City of Greenville, known and designated as Lot No. 69 in Block D of the Subdivision known as Augusta Court, as shown on a Plat of record in the R.M.C. Office for Greenville County, S. C., in Plat Book F, Page 124, and having, according to said Plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Northwest side of Augusta Court, joint corner of Lots Nos. 69 and 70; thence with the joint line of said lots, N. 39-24 W. 160.4 feet to an iron pin, joint corner of Lots Nos. 57 and 69; thence with the joint line of said lots, S. 51-20 W. 59.83 feet to an iron pin, joint corner of Lots Nos. 68 and 69; thence with the joint line of said lots, S. 39-22 E. 164.8 feet to an iron pin on Augusta Court; thence with Augusta Court N. 47-10 E. 60 feet to the point of beginning; being the same property conveyed to the mortgagor by Melville C. Westervelt, as Trustee, by deed recorded in Volume 275 at Page 248."
