TO ALL WHOM THESE PRESENTS MAY CONCERN:-----THIRD PRESBYTERIAN CHURCH, of Greenville, S. C.

----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of THIRTY FIVE HUNDRED & NO/100 -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, just outside the City of Greenville, on the South side of Mountain View Avenue, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of of Mountain View Avenue, which pin is 500 feet west of the southwest corner of the intersection of Mountain View Avenue and Townes Street and running thence S. 10-15 W. 170.5 feet to an iron pin on the north side of an alley; thence along the north side of said alley N. 79-45 W. 50 feet to an iron pin; thence N. 10-15 E. 170.5 feet to an iron pin on the south side of Mountain View Avenue; thence along the south side of Mountain View Avenue S. 79-45 E. 50 feet to point of beginning.
