MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, H. H. Camp

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-five Hundred and No/100 DOLLARS (\$ 3,500.00-), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, situated on the Southern side of West Washington Street in the City of Greenville, and located directly opposite the intersection of Butler Avenue and said West Washington Street, having the following metes and bounds, to-wit:

"BEGINNING at the corner of a lot formerly owned by Dean and running thence along the line of said lot, S. 19 1/4 W. 217 1/2 feet to an iron pin; thence N. 66 1/2 / 79 1/2 feet to pin; thence in a Northerly direction to the center of the circumference of a well on the Southern side of said lot; thence around the Western side of said well to the center on the Northern side; thence in a Northerly direction to a point on Washington Street, 72 feet from the beginning corner; thence along said Washington Street, S. 66 1/2 E. to the beginning corner; said premises being the same conveyed to the mortgagor by Lillie May Wertz, W.
