MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Thomas C. Hawkins and Mildred C. Hawkins

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Hundred and No/100 DOLLARS (\$ 1200.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, on the Eastern side of Second Avenue (formerly Webster Street) in the village of Slater, being shown as Lot No. 28 of Block D on Plat of property of S. Slater and Sons, Inc., made by J. E. Serrine and Company July 10, 1940, recorded in Plat Book K at page 64, and described as follows:

"BEGINNING at a stake on the Eastern side of Second Avenue, 285 feet North from Edison Street, at corner of Lot No. 29, and running thence with the line of said Lot, N. 87-26 E. 125 feet to a stake at corner of Lot No. 5; thence with the line of said lot, N. 2-34 W. 70 feet to a stake, corner of Lot No. 27; thence with the line of said lot, S. 87-26 W. 125 feet to a stake on Second Avenue; thence with the Eastern side of Second Avenue, S. 2-34 E. 70 feet to the beginning corner; said premises being the same conveyed to the mortgagors by Marie Wilson Bridges by deed of even date to be recorded herewith."
