MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Frank Ferguson

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Parker Road, near the City of Greenville, and described as follows:

"BEGINNING at an iron pin on the Eastern side of Parker Road, corner of property of A. S. Chaney, and running thence with the line of said property, N. 56 E. 250 feet to an iron pin, corner of property of Homer A. Farr; thence with the line of said property, S. 59 E. 135 feet to a stake in line of Cureton property; thence with the line of said property, 42 feet to a stake, corner of property of Irene W. Machen; thence with the line of said property, N. 44 W. 63 feet to a stake; thence continuing with said property, S. 56 W. 250 feet to a stake on Parker Road; thence with the Eastern side of Parker Road, 63.5 feet to the beginning corner; said premises being the same conveyed to the mortgagor by Irene W.
