MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I , JOSIE B. BREZFALE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ELEVEN HUNDRED AND NO/100 ----- DOLLARS (\$ 1100.00 -----), with interest thereon from date at the rate of six (6%) ----- per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, In Greenville Township, on the southwestern side of Sycamore Drive, near the City of Greenville, known as Lot No. 113 on plat of East Lynne Addition, made by Dalton & Neves, Engrs., May, 1923, recorded in R.M.C. Office for Greenville County, in Plat Book "H" at page 220, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Sycamore Drive at joint front corners of Lots 112 and 113, and running thence with the line of Lot No. 112 S. 28-35 W. 198 feet to an iron pin; thence S. 63-51 E. 50 feet to an iron pin; thence with the line of Lot No. 114 N. 28-35 E. 195.7 feet to an iron pin on southwestern side of Sycamore Drive; thence with the southwestern side of Sycamore Drive N. 61-10 W. 50 feet to beginning corner; being the same property conveyed to the mortgagor by deed dated May 15, 1945 recorded in Book of Deeds 281 at page 237.
