MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, J. T. Barker
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, on the North side of the Buncombe Road, adjoining lands now or formerly owned by T. H. Peterson, J. E. Child and Case Estate, known as a portion of the land conveyed to T. H. Peterson by deed from Nellie Tollison, and being more particularly described by metes and bounds, as follows:

"BEGINNING at an iron pin on the Buncombe Road; thence S. 54 W. 72 feet to an iron pin; thence N. 32 W. 261 feet to an iron pin; thence N. 78 E. 130 feet to an iron pin; thence S. 17 1/2 E. 218.8 feet to the beginning corner, and containing .53 acre, more or less; being the same premises conveyed to the mortgagor herein by T.
