WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the north side of Seventh Street, in Section No. 4 of Judson Mills Village, near the City of Greenville, being known and designated as Lot No. 40 as shown on plat of Section No. 4 of Judson Mills Village, made by Dalton and Neves, Engr. January, 1941, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book K at pages 75 and 76 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Seventh Street, joint front corners of Lots 40 and 41, and running thence with line of Lot 41 N. 1-42 W. 122.5 feet to an iron pin; thence N. 88-10 E. 70.4 feet to iron pin; thence S. 1-42 E. 109.2 feet to iron pin on the north side of Seventh Street; thence with the north side of Seventh Street on a curved line S. 77-28 W. 71.7 feet to beginning corner.
