(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Eastern side of First Street (formerly Melon Street) at Slater, South Carolina, being shown as lot No. 20 of Block "H" on plat of the village of S. Slater & Sons, Inc. made by J. E. Sirrine & Company on July 10, 1940, recorded in Plat Book "K" at Pages 65 and described as follows:

BEGINNING at a stake on the Eastern side of First Street, corner of lot No. 21 and running thence with the line of said lot N. 82-41 E. 124 feet to a stake, corner of Lot No. 3; thence with the line of said lot N. 7-24 W. 70 feet to a stake, corner of lot No. 19; thence with the line of said lot S. 82-41 W. 124 feet to a stake on First Street; thence with the Eastern side of First Street S. 7-24 E. 70 feet to the beginning corner; being the same property conveyed to the mortgagor by deed of Carl Hill to be recorded herewith.
